The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/07/2021 at 2332 hours I conducted a traffic stop on a gray 2016 Ford F-150 pickup, FL tag 755QWX after I observed the vehicle driving the wrong way on a one way street, southbound on Howard Av S from Kennedy Bl E. Howard Av S is northbound only at this location. Upon contact with the driver of the vehicle, defendant Nicole Maria Preston, I observed that she had glassy eyes and then as I explained to her why I had stopped her I detected a very strong and distinct odor of an alcoholic beverage. The defendant then admitted to having a couple of drinks. I then asked the defendant to exit the vehicle and she exhibited additional signs of impairment during the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 2345 hours. I then transported the defendant to the HCSO/CBT Facility where she refused to submit to a breath test. Implied Consent was read at 0022 hours on 03/08/2021. I identified the defendant with a valid FL DL.
