

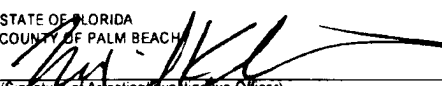

The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody ☐ committed the below acts in my presence ☐ was observed by _____ who told _____ ☐ confessed to _____ that he/she saw the arrested person commit the below acts. ☒ was found to have committed the below acts, resulting from my (described) investigation. On the 16 day of April 20 22 at 0200 ☒ A.M. ☐ P.M. (Specifically include facts constituting cause for arrest.) On Saturday, April 16, 2022 at approximately 0200 hours I was dispatched to 1741 4th Avenue N apartment 4 located within the City of Lake Worth Beach in Palm Beach County Florida for a report of a domestic disturbance. The caller stated his wife was possibly intoxicated and banging on the front door. The call taker also noted they heard a female yelling and banging in the background of the call. Upon arrival I exited my marked patrol vehicle which was parked just east of the location and could hear a female screaming and loud banging. It should be noted I was wearing my full issued PBSO class "B" uniform with all badges, name plates, duty gear, and insignia visible, readily identifying me as a PBSO deputy. A white female in a black shirt and blue jacket, later identified as Nicole Hochstadt, approached me yelling saying her husband, later identified as Seth Hochstadt, would not let her inside her house. As she spoke I detected an odor of an unknown alcoholic beverage and her speech was slurred. Hochstadt stated she just home from work at a bar called the Hive. I asked Hochstadt how I could help her and she said I needed to make her husband open the door and let her inside. I attempted to explain to her that I could not force her husband to do anything. Before I could finish speaking Hochstadt threw her hand in the air and stated "I'm done with you" and walked away from me. She then began banging loudly with her hand on apartment door 4. I told Hochstadt I was not finished speaking with her and conducting my investigation. I approached Hochstadt and told her to stop banging on the door and causing a disturbance. She turned around, took multiple steps towards me, started pointing at me and screaming. She said that she was going to get into her house no matter what and yelled several profanities. Due to her erratic behavior and being the only deputy on scene I attempted to detain Hochstadt. I stated she was being detained and gave her a command to put her hands behind her back. Using my left hand I grabbed her right wrist in order to place her in handcuffs. Hochstadt immediately pulled away from me and put her back against her front door. I told her again to put her hands behind her back and to stop resisting. She continued to ignore my commands and held her hand close to her abdomen says she was not detained and to get my hands off of her. At that time D/S Hentze #26709 arrived on scene and assisted in attempting to detain Hochstadt. She continued to actively resist by pulling her arms away from me, turning towards me and refusing to submit to handcuffs. She was escorted to the ground where she continued to actively resist by pulling her right arm underneath her body. D/S Hentze had control of Hochstadt's left wrist which I was able to secure in handcuffs. I was then able to remove her right arm from underneath her and secure her right wrist. Once properly secured in PBSO issued handcuffs I checked them for proper fit and double locked them. We then attempted to escort her to my patrol vehicle where she continued to actively resist by sinking her weight to the ground and refusing to walk. I instructed Hochstadt to stop resisting and walk on her own. She began to walk and was then secured in the prisoner compartment of my patrol vehicle. Due to the use of control Lt. Johnson #9724 responded to the scene. Lt. Johnson requested to take photographs on Hochstadt for documentation purposes and opened the door to the prisoner compartment. Hochstadt abruptly exited the vehicle and stepped towards Lt. Johnson, at which time Lt. Johnson stepped back. Hochstadt then reared her head back and spit at Lt. Johnson. Her saliva landed on Lt. Johnson's right pant leg. Due to the fact she spit and made threats to continue to spit an agency issued spit mask was placed on Hochstadt's face. Based on the above stated facts I find probable cause exists to arrest Hochstadt for Battery on a Law Enforcement Officer pursuant to F.S.S. 784.07(2b) as well as Resist w/out violence pursuant to F.S.S. 843.02.
