## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.  
On 09/25/20 at 2157hrs, Ofc. E. Hernandez #1194 DBPD observed a gray 2019 Jeep Cherokee (FL Tag #DSA1G) fail to stop properly at the intersection of SW 10th Ave. and Lindell Blvd. The intersection is a three-way intersection with all directions having a stop sign and white stop bar on the roadway. The Jeep was traveling west on Lindell Blvd. and failed to stop prior to the stop bar at the intersection. The Jeep stop passed the stop bar and proceed to turn right (north) onto SW 10th Ave. Ofc. E. Hernandez conducted a traffic stop by activating his emergency lights and the Jeep pulled over north of the intersection. I met with the white female driver and identified her by her FL DL as Nicole Joy Urban. Urban was the only person inside the Jeep. The Jeep's engine was running and the vehicle key was inside the Jeep. Urban stated she was driving to her residence when she got pulled over. Ofc. e. Hernandez did not lose sight of the Jeep from the traffic violation location to the traffic stop scene.

## OBSERVATION OF DRIVER:

I smelled an odor of an unknown alcoholic beverage coming from Urban. Urban's eyes were red and glassy. Urban's speech was slurred and appeared to have a slow reaction to questioning. Urban stated she was confused and did not know what was happening.

## DRIVER'S STATEMENTS:

Urban stated she was out with a friend at an unidentified business. Urban stated she consumed one glass of wine at the business. Urban stated she went back to her friend's residence near a Walgreens at Lindell Blvd. and S. Federal Hwy. in Delray Beach, FL. Urban stated she consumed two more glasses of wine at her friend's residence. Urban stated she finished her last glass of wine 30 minutes prior to the traffic stop. Urban stated she was on her way home when she was pulled over. Urban stated she was close to home and did not understand what she did wrong. Urban stated she felt the effects of alcohol from the glasses of wine. Urban refused to perform roadsides because her friends instructed her to refuse. I explained Taylor Warning to Urban and she stated she understood but still refused roadsides. Urban stated she was a good person and did not have any intent to hurt anybody.

Urban had a strong odor of an unknown alcoholic beverage coming from her person.
