at approximately 10:23 PM, at BAYSIDE BRIDGE (SOUTH BOUND), in Pinellas County did:

REASON FOR STOP:

THE DEF WAS OBSERVED IN ACTUAL PHYSICAL CONTROL OF HIS VEHICLE WHEN HE WAS OBSERVED BY OFFICER HURT TO BE DRIVING AT A HIGH RATE OF SPEED SOUTH BOUND ON THE BAYSIDE BRIDGE. THIS OFFICER WAS ABLE TO CAPTURE THE SPEED OF THE VEHICLE TO BE 96 MPH IN A 55 MPH ZONE. THIS OFFICER INITIATED A TRAFFIC STOP AND OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLOWED SLURRED SPEECH, SWAYING BACK AND FORTH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE ON HIS BREATH AND PERSON. THE DEF PARTICIPATED IN SFST AND PERFORMED POORLY ON ALL SFST. THE DEF THEN PROVIDED 2 BREATH SAMPLE SHOWING HIS BRAC WAS 0.096 AND 0.096.

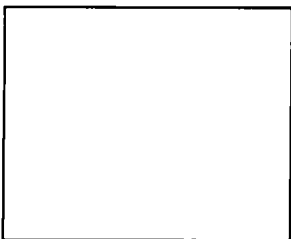
