The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On Sunday, November 24, 2019, at approximately 2:24 am, I Trooper Warren N Reid was dispatched to a traffic crash which occurred on State Road 618 eastbound in downtown Tampa. When I arrived on scene I observed a black sedan blocking the inside eastbound lane facing south. I approached the driver door and observed the defendant sitting in the driver's seat. While talking to the defendant, I observed she had bloodshot, watery eyes and was slurring in her speech. After completing my traffic investigation, I informed the defendant that I had concluded the crash investigation and was now conducting a criminal investigation for DUI. I asked the defendant if she was willing to perform some Field Sobriety Exercises and she agreed. I explained the Gaze Nystagmus to the defendant and she was not able to follow the stimulus light with eyes only, but kept turning her head. During the walk and turn, she started walking before I finished giving the instructions, she took the incorrect number of steps, failed to keep hands at her side and failed to maintain her balance. During the One Leg Stand, defendant was unable to maintain balance and wasn't able to perform the exercise. She was identified by her Florida Driver's License as Nishita Varde and I then informed her that she was under arrest for DUI. She was then handcuffed behind her back, placed in the back seat of my marked patrol car. I requested a breath sample and she refused. I read her the Implied Consent Warning and she agreed to provide a sample at the jail. She was later transported to the Orient Road Jail. This offense committed in Hillsborough County.
