 The defendant was stopped for speeding (paced in excess of 80 MPH in a 40 MPH zone). The defendant was driving his 2013 Ford Mustang, bearing FL tag #LMXJ16. Upon making contact with the defendant, he displayed multiple indicators of impairment, including: a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, fumbling fingers, open container of alcoholic beverages in his vehicle, and admission to consuming 3 alcoholic beverages. The defendant performed the SFSEs, exhibited multiple clues of impairment, and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .133/.118.
