DURING A SEARCH OF THE VEHICLE THE DEFENDANT WAS A PASSENGER OF. A ROLLED UP TWENTY DOLLAR BILL WITH A WHITE POWDERY SUBSTANCE WAS FOUND IN THE PASSENGER SIDE DOOR. AFTER MIRANDA THE DEFENDANT ADMITTED TO USING THE TWENTY DOLLAR BILL EARLIER WITH COCAINE. THE DEFENDANT THEN ADMITTED TO HAVING MORE COCAINE IN A SMALL BAG FOUND IN HIS RIGHT FRONT POCKET.

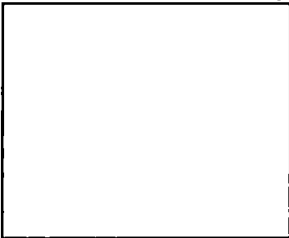
