Once they got to the front door, Novean grabbed Yanisa by the hair and threw her to the ground. Yanisa stated that she attempted to stand up and Novean grabbed her by the hair again and threw her to the floor. This happened multiple times until Novean grabbed Yanisa by the throat with one hand and forced his fingers into her mouth with his other hand. Yanisa stated that she was not able to breathe. Yanisa stated that Novean released her and left the residence.

Yanisa located her phone and called the police. Yanisa had four scratch marks to her neck, three to the left side of her neck and one on the front of her throat. The injuries were consistant with the allegations. Yanisa has two children with Novean.
