On the above date and time. I responded to 1000 N Congress Ave, in unincorporated West Palm Beach. In reference to a assault. I was operating as a single-man unit, utilizing a Palm Beach County Sheriff's Office unmarked vehicle, which is equipped with emergency red/blue lights and sirens. Additionally, I was wearing PBSO issued tactical vests with "SHERRIFF" patches on the front/back, Sheriff badges on my chest, and PBSO issued long sleeve shirts with "SHERIFF" on the sleeve, clearly identifying us as Law Enforcement.

Upon my arrival, I made contact with Mario Rinaldi who is the manager at the business Monroe's of Palm Beach. Rinaldi had a white male later identified as Lucian Puscasu on the floor because Puscasu had just assaulted multiple subjects. Refereed to case number 21-125414. I proceeded to detained Puscasu. While helping Puscasu to sit up and hispanic male identified as Odani Garcia proceeded to walk towards me in a very aggressive manner. I stood up and order Garcia to back off to a safe distance to I can continued with my investigation, also should be noted I was the only unit on the scene. The male refused to backup and proceeded to say " I didn't commit any crime". I proceeded to order Garcia for the second time by giving him a lawful order. Garcia proceeded to raise his right hand towards my face thats when I attempted to place Garcia under-arrest. Garcia proceeded to tensed up both of his arms making it hard for me to detain him. Proceeded to use my body to place Garcia on his stomach and I was finally able to detained him.

Base on the above information I found enough probable cause to charge Garcia with one count of resisting with out violence per F.S.S 843.02. Garcia was transported to the Palm Beach County Jail without incident.
