 On the 18 day of August, 2020 at 20:43 (Specifically include facts constituting cause for arrest.)

n Tuesday, August 18th, 2020 at approximately 20:12 hours, Riviera Beach officers, responded to 3900 W. Blue Heron Blvd. in the City of Riviera Beach, Palm Beach County, FL in reference to an Accident with injuries.

Upon arrival Riviera Beach officers, made contact with Jimmy Santiago (H/M, 03/26/91) and Maria Flores (H/F, 06/29/98) who were involved in the accident. Flores was complaining of back injuries and Santiago complained of pain to his side. The couple stated that they were in the far left turning lane traveling West on W. Blue Heron Blvd. stopped at the first set of traffic lights prior to I-95. While waiting for their traffic light to change from steady red to green indication light a white 4- door sedan struck their vehicle coming off I-95 North bound. The white sedan failed to stop at it's steady red indication light struck the positive medium barrier and then struck the 2007 Silver sedan 4-door (bearing FL-Tag PHW 9Q) that was occupied by Santiago and Flores causing major front end damage to the vehicle.

Flores and Santiago notified Riviera Beach Police Communications Department that the driver of the white 4-door Acura (bearing FL- Tag Z20 DFD) left the scene walking fast east on W. Blue Heron Blvd.

Suspect description: White male wearing pink colored shorts and blue shirt.

Riviera Beach officers, canvassed the area and located a white male who fit the description of the subject later identified as Oleg Tchoumak (W/M, 05/12/73) at 7290 Central Industrial the business of Shell gas station. Santiago and Flores were taken to do a show up at 7290 Central Industrial to positively identify the driver of the 2015 White Acura (FL-Tag Z20 DFD) left at the scene. Santiago and Flores positively identified Tchoumak as the subject that was observed driving the above white Acura that struck their vehicle, and then left the accident scene.



Tchoumak was transported by Riviera Beach Fire Rescue 87 to JFK Medical Center for medical treatment. Tchoumak was yelling profanities and combative he was arrested for DUI- Driving Under the Influence pursuant to F.S.S. 316.193(1), Accident- w/injures fail to remain pursuant to F.S.S. 316.027(2) (A), and DL- No Drivers License issued pursuant to F.S.S. 322.03(1).

Tchoumak was explained the purpose of the blood draw to determine his alcohol content. Which he later refused the blood draw by JFK Medical staff Paramedic Sandro. Tchoumak was read his Miranda warnings. He gave a brief statement and admitted to taking medication that he was not suppose to take while driving, however he could not remember the name of the medication. Tchoumak admitted to driving the white Acura.

Tchoumak due to his incapacitated state was unable to perform any road side Field Sobriety Task. Tchoumak was transported for medical treatment and later transported to the Palm Beach County Jail.
