The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a silver 2015 BMW 4-door (FL TAG #EDGV94) westbound on Kennedy Bl W in the right lane, when he drifted out of his lane and into mine. This caused me to swerve to avoid an accident, then follow behind him as he continued to drive westbound. While following behind him, I observed his vehicle to weave back and forth within it's lane and drift over the lane divider line. During the traffic stop for the infraction and the other suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, slurred speech, slow/uncoordinated movements, appeared lethargic/tired, poor balance, confusion (rolled his window up & down while trying to open his door), admitted to drinking a few drinks while at a work-related Christmas party, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent, but still refused to provide a breath sample.
