The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white 2021 Dodge Ram pick-up *FL TAG #CXD4811) southbound on Dale Mabry Hwy N, when he ran the steady red light at Kennedy Bl W as he was turning westbound (right turn). While following behind the defendant, I also paced his vehicle at 65 MPH in a posted 45 MPH zone and watched as he drifted out of his lane and over the lane divider line. During the traffic stop for the traffic infractions and the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, confusion, poor balance, admitted to drinking wine prior to driving, and had a distinct odor of an alcoholic beverage stemming from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he willingly provided 2 valid breath samples, measuring .015/.015 BrAC. Because the defendant's level of impairment was not consistent with his breath results, and because he eluded to taking allergy medication prior to driving, I requested a urine sample from the defendant. He refused, so I read him Implied Consent. When asked again, he refused a second time.
