<p>This incident occurred in the City of Delray Beach, Palm Beach County, FL.</p> <p>On 11/18/2020, at approximately 0041 hours, I responded to the area of 5 SE 2nd Ave regarding a hit-and-run vehicle crash. An anonymous witness contacted police after observing the suspect, later identified as Omar Shaqaqi, attempt to make a 3-point turn and crash the rear right of his vehicle against the rear left of a parked vehicle. Shaqaqi's vehicle was a gray 2020 Chevrolet Silverado bearing FL tag IMHG30. The parked vehicle was a Hertz rental gray 2020 Chevrolet Malibu bearing FL tag NFNV09.</p> <p>Upon my arrival, the renter of the Chevrolet Malibu, later identified as Jeffrey Rectenwald, approached me with his friend, Thomas Zaines, and advised me of the following in sworn statements: on this date, he had parked the vehicle on the East side of the 1-blk of SE 2nd Ave. Zaines returned to the vehicle later in the night and saw Shaqaqi standing by the vehicle. Zaines approached him and saw that Rectenwald's vehicle had been struck on the rear left bumper. He then asked Shaqaqi if he saw who had crashed into the vehicle and Shaqaqi stated yes, he did it. Zaines then advised him to wait while he fetched Rectenwald. When Zaines and Rectenwald returned and made contact with Shaqaqi, they agreed to resolve the crash amongst themselves and exchange information. Shaqaqi and Zaines exchanged phone numbers and, Zaines attempted to get information from him via phone with negative results. They observed as Shaqaqi walked over to Salt 7 (32 SE 2nd Ave) and sat at the bar. Zaines and Rectenwald then approached Shaqaqi at the bar and requested for him to provide information for the crash. Shaqaqi then advised them that he had no information on him to provide to them. Rectenwald further advised me that he wanted to report the crash in order to ensure he had Shaqaqi's information for the damages to the vehicle.</p> <p>I then made contact with Shaqaqi and his girlfriend, Jenna at the Salt 7 bar and advised them that I was conducting a crash investigation and needed his information because he</p>

<p>was involved. Jenna immediately began yelling and stating that he did not need to provide any information. I advised her that I did not need his information as she was not driving the vehicle and again request Shaqaqi for his. At this point, Shaqaqi advised me that he had no information on him and that he was not going to provide me with any information. I then requested for another officer for back-up and Ofc. Hernandez #1194 responded.</p> <p>I briefed Ofc. Hernandez as to the incident up to this point. While speaking with Ofc. Hernandez, we observed as Shaqaqi and his girlfriend, stood up from the bar and walked inside of Salt 7. While waiting for them to exit the premises, I made contact with a witness to the crash (See DBPD Case #20-015068 for further). After a couple of minutes, Shaqaqi's girlfriend exited the premises and Shaqaqi followed shortly thereafter. Ofc. Hernandez and I then made contact with Shaqaqi and attempted to explain to him that we needed his information due to him being involved in a crash. Shaqaqi immediately became belligerent and started yelling that he did not need to give us anything and that he will make sure we did not have a job next year for detaining him. His girlfriend returned and also became belligerent. Officers advised then advised him that failure to provide information after a crash was a criminal and arrestable offense. Shaqaqi then proceeded to contact 911 multiple times requesting for supervisors because officers on scene were 'threatening to arrest him and not letting him leave' (see BWC footage for exact statements). Sgt. Grammatico responded, along with Ofc. Tabares, Ofc. Mitchell and Ofc. Mintus (see officers/sergeant's supplements for further). Per Sgt. Grammatico, after making contact with Shaqaqi, he immediately became confrontational and began yelling and threatening officers on scene. Shaqaqi kept standing up with his fists clenched and sitting back down while still yelling and causing a ruckus. During this encounter, all occupants and staff members of Salt 7 came outside and passersby had gathered around Shaqaqi and officers. Sgt. Grammatico then attempted to make contact with me and provide me with Shaqaqi's information for the crash investigation. When he returned, he observed as Shaqaqi and his girlfriend were once again standing up, yelling and threatening officers. His girlfriend then engaged in a verbal confrontation with Rectenwald, which caused Shaqaqi to engage in the confrontation as well. Officers attempted to separate all parties at which time Shaqaqi began to threaten Sgt. Grammatico and took an aggressive stance. Shaqaqi kept getting closer to him while clenching his fists. Sgt. Grammatico gave him multiple commands to back up while at the same time backing up himself to create distance between them. Sgt. Grammatico then advised Shaqaqi that due to the totality of circumstances, he was under arrest. Ofc. Mintus and Mitchell attempted to gain control of Shaqaqi's right arm while Ofc. Tabares and Sgt. Grammatico attempted to gain control of his left arm. Shaqaqi was able to pull his arms away from officers due to his overpowering strength and refused to comply with commands. Officer Mintus disengaged, drew his department issued Taser and, gave him multiple commands which Shaqaqi refused to comply with. At this point, Sgt. Grammatico advised officers to take Shaqaqi to the ground to gain compliance due to his lack of cooperation, strength and increasing agitated state. Once on the ground, Sgt. Grammatico</p>

and Officers Tabares, Mintus and Mitchell were then able to place Shaqaqi in handcuffs, but he continued to pull away from officers. Shaqaqi was then walked and escorted to my marked patrol vehicle #732.

Based on the above stated facts, Probable Cause exists to charge Omar Shaqaqi with one count of Disorderly Intoxication in violation of FSS 856.011 and one count of Resist Officer W/O Violence in violation of FSS 843.02.
