UPON ATTEMPTING TO STOP THE VEHICLE HE WAS SLOW TO REACT AND WOULD CONTINUE DRIVING THROUGH A PARKING LOT. HE WOULD STOP AND THEN PROCEED FORWARD, AND STOP AND PROCEED FORWARD. I HAD TO COMMAND THE DEFENDANT TO PLACE THE VEHICLE IN PARK. WHILE SPEAKING WITH THE DEFENDANT I COULD SMELL THE VERY STRONG AND OBVIOUS ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS MOUTH THAT WOULD GROW STRONGER WHEN HE SPOKE. HIS EYES WERE BLOOD SHOT AND WATERY. UPON EXITING THE VEHICLE HIS BALANCE WAS UNSTEADY AND HE WOULD SWAY AND STAGGER AND LEAN AGAINST HIS VEHICLE. 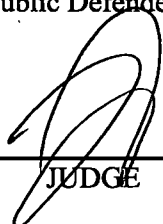
ADVISORY AND SOLVENCY HEARING

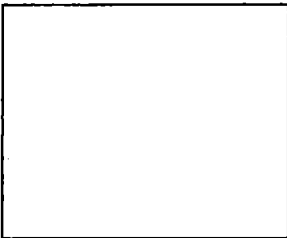
