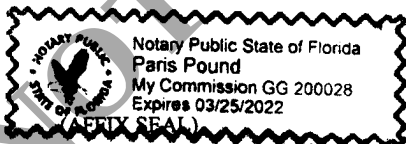

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Sunday March 20th 2022 at approximately 2009 hours, I arrived at 3667 120th Ave S, in the City of Wellington, FL 33414 in reference to a traffic stop conducted by Deputy Alme ID# 29795. Upon arrival he relayed the following to me: On 03/20/2022 at approximately 19:52 hrs I was dispatched to 3667 120th Ave S Wellington, FL 33414 in reference to an intoxicated male and female. According to the complainant, the two individuals were trying to drive to Miami, FL with a two year old child in the vehicle. The complainant described the vehicle as a blue Honda SUV. Upon my arrival, I observed the described vehicle driving north through the parking lot. I initiated a traffic stop on the Blue Honda CRV bearing FL tag #PZVQ08. A white male driver later identified as, Oscar H Berrio, exited the vehicle stumbling. I could smell the odor of an unknown alcoholic beverage coming from his person. Oscar's speech was slurred as he mentioned he had an alcoholic beverage while attending a Polo match. This concludes his supplement. In the vehicle was his female partner and 25 month old (2 yoa) child who was sleeping in the her car seat.

OBSERVATION OF DRIVER:

I observed the defendant, Oscar H. Berrio who was wearing a white long sleeve shirt, pink pants and no shoes. The defendant was standing outside the vehicle with Deputy Alme. I spoke with the defendant and had another Deputy walk him over to the tennis court nearby. While walking over, the defendant was unsteady on his feet and staggered as he walked. While standing stationary the defendant swayed. I could see the defendants eyes were bloodshot and glossy. He had an obvious odor of an unknown alcoholic beverage emitting from his breath that grew stronger as he spoke. The defendants speech was slow, slurred and at times unclear.

DRIVER'S STATEMENTS:

The defendant said he did not have any physical defects or preexisting injuries, diabetes, or wear glasses. The defendant said he had champagne and 2 glasses of wine to drink. The defendant said he moving his car because the staff said he had to, he could not leave it where it was parked. He said he was driving the vehicle. I asked the defendant to submit to roadside field sobriety tasks to which he agreed.

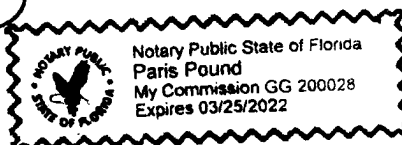

The defendant swayed while standing stationary. I had to remind the defendant to not turn his head. I had to remind the defendant to follow the red light with his eyes.

WALK & TURN:

The task was explained and demonstrated. The defendant stated he understood the instructions. During the task the defendant failed to maintain the instructional stance. The defendant swayed while standing stationary. The defendant used his arms for balance throughout the task, did not touch heel to toe multiple times, stopped to regain balance, stumbled as he attempted to regain his balance.

ONE LEG STAND:

The task was explained and demonstrated. The defendant stated he understood the instructions. The defendant swayed while standing stationary. During the task the defendant used arms for balance, put his foot down before 30 seconds elapsed.

FINGER TO NOSE:

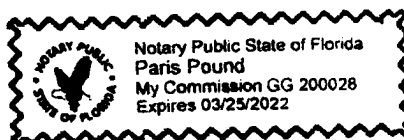
