The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a 2012 silver Kia 4-door bearing a Florida license plate of 7415JM. She was traveling north on S Howard Ave approaching W Platt St where there was a steady red light. The defendant did not slow down or attempt to stop at this red light. The vehicle then made a wide right turn onto Kennedy Blvd and nearly struck the center median curb. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, swaying, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
