The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 06/17/2020, at 2230 hours, the District V Street Crimes Unit served a court authorized search warrant at 118 Elderberry Ln. While serving the search warrant, the defendant was located on a couch in the living room of the residence. Next to the defendant, I located one clear "bubble" pipe which is generally used to ingest illegal narcotics and a small grey scale. During a post Miranda interview, the defendant admitted to having illegal narcotics and pointed to a hole in the wall. I removed two clear plastic baggies from the hole in the wall. Inside each baggie was a clear crystal like substance. The substance later tested positive for Methamphetamine using a HCSO issued field reagent test kit. The defendant was identified by her FL driver's license.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
