The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant, who was identified by her Florida driver's license, was stopped for failing to drive within her lane, weaving and changing lanes / turning without using a turn signal. The defendant's driving patter was indicative of an impaired driver. Upon making contact with the defendant I observed that her eyes were glassy and there was a distinct odor of an alcoholic beverage emitting from her breath. The defendant initially stated she'd had nothing to drink, then stated she'd had a glass of wine, then later claimed she'd had 1 1/2 drinks. The defendant was administered a series of SFST's which she was unable to perform satisfactorily. Post Miranda, she admitted to having a "buzz" from the alcohol and had intended to catch an Uber but didn't have the cash. Based upon the above I arrested the defendant for DUI and transported her to CBT where she was administered a breath test. The defendant's BrAC measured .185 / .172. This occurred in Hillsborough County, Florida.
