The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant drove down an alley and crashed and sideswiped multiple gutter down-spouts. The defendant was positively identified as the driver at the time of the crash and was still in actual physical control of the vehicle, attempting to back out of the alley, upon police arrival. The defendant was driving her 2008 Toyota Camry, bearing FL tag EMIP35. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, swaying as she stood, and post-Miranda admission to consuming alcoholic beverages. The defendant performed poorly on the SFSEs and was arrested for DUI with property damage. The defendant later submitted to the breath test, which had a BrAC of .164/.166.

The defendant identified herself via her FL driver's license.
