The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The victim and defendant have been married for approximately 6 years and reside together as a family with one child in common, who is 22 months old. On 09-12-21, the two were involved in a verbal altercation which turned physical when the defendant intentionally struck the victim in the mouth with an unknown object, then pulled her hair, and repeatedly hit the victim with his shoes on the arms while insisting she leave the residence. The victim responded to an urgent care for treatment of her injuries on 09-13-21, and police was notified of the crime. I observed a cut bottom lip on the victim and her left pointer finger was in a splint, but not broken according to the Dr. The victim also complained that the back of her head still hurt from her hair being pulled.

The defendant was positively identified by FL DL G430671750200.
