The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 06/28/2020, at approximately 1937 hours, Deputy Koehler responded to the Thornton's located at 6405 Hillsborough Av W in reference to a reckless driver. The witness contacted HCSO after observing the defendant driving a beige Toyota Corolla with extensive front end damage. The witness noted the front passenger tire was completely gone and only had the metal rim remaining. Deputy Koehler arrived on scene and observed a 2010 beige Toyota Corolla bearing FI tag 927MSM (VIN: NXBU4EE3AZ225964) parked at the Thornton's gas pump. Deputy Koehler observed the defendant attempting to fill the car with gas, however, the pump had been turned off by the witness and no gas was being dispensed. During the investigation, Deputy Koehler learned the defendant was involved in a traffic crash at an unknown location within the prior 40 minutes. The defendant was unable to provide HCSO with a location the event occurred. In addition, HCSO was unable to locate the location. It should noted, the defendant admitted post Miranda, that she is the owner of the Toyota and the only person with access to the vehicle. In addition, the defendant admitted to being the sole driver of the Toyota for the entirety of the day. The defendant advised the vehicle was in proper working condition when she left Bobalouie's Sports bar several hours prior. The defendant advised the collision happened somewhere in between the bar and the Thornton's. Deputy Koehler noted the keys were in the possession of the defendant and video surveillance at the Thornton's captured the defendant operating the vehicle as the sole occupant. As Deputy Koehler spoke to the defendant, he noticed several indicators of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant provided a lawful breath sample that resulted in a BAC of .109/.109. The defendant was identified via FL DL.

Total known damage to the Toyota is valued at approximately \$10,000.
The defendant has 1 prior DUI convictions dated 01/19/2007.
