

Florida. Trooper Yepez requested a DUI Unit, myself, in reference to a possible impaired driver (See Trooper Yepez's incident report when completed).

Upon arrival on scene, I made contact with the driver, identified via his Ohio DL as Patrick A. Johnson. I immediately smelled the odor of an alcoholic beverage emitting from within the vehicle. Mr. Johnson's eyes appeared watery and glassy. Mr. Johnson's eye's were bloodshot. I asked Mr. Johnson where he was coming from, which he stated "Ft. Lauderdale". Mr. Johnson stated he was going to Delray Beach from Ft. Lauderdale (It should be noted that Mr. Johnson was traveling south from Boynton Beach). Mr. Johnson's speech appeared to be slurred. I smelled the odor of an alcoholic beverage emitting from Mr. Johnson's breath as he spoke.

At that time, I requested Mr. Johnson to step out of the vehicle. Mr. Johnson appeared uneasy on his feet as he leaned up against his vehicle. I requested that Mr. Johnson participate in Standardized Field Sobriety Tasks (SFST's), which he voluntarily agreed.

Mr. Johnson performed poorly on all SFST's (see full completed incident report, DUI packet, and dash-cam video for details). At that time, due to Mr. Johnson's driving behavior, personal interaction, and SFST performance, I concluded that Mr. Johnson's normal faculties were impaired at the time he operated a motor vehicle. Mr. Johnson was arrested for driving under the influence at 0008 hours. Mr. Johnson was searched incident to arrest and placed in the rear of my patrol vehicle. Mr. Johnson started tensing up and kept asking what he did wrong. Mr. Johnson eventually calmed down and was placed in the rear of my patrol vehicle. Mr. Johnson kept repeating his questions, even after I answered them.

Mr. Johnson was transported to the Palm Beach County Jail without incident. Mr. Johnson was observed for twenty (20) minutes. I requested that Mr. Johnson provide a sample of his breath, which he would not answer. Mr. Johnson kept asking a question constantly. Mr. Johnson was read implied consent at 0110 hours. Mr. Johnson refused to provide a sample and stated "no" after asking him once again. Mr. Johnson was transferred into the custody of the Palm Beach
