

Through investigative means, it has been determined that the suspect, Patzy Aburto, utilizes the social media application, "INSTAGRAM" to advertise and arrange the distribution of the counterfeit items.												
Aburto's Instagram has 379 "posts" of luxury branded items. Various photographs have a large font including the price of the item. I contacted Investigator J. Berger of "A ACTION INVESTIGATIONS & SECURITY INC." who is trained and hired by luxury brands, such as Chanel and Louis Vuitton, to identify counterfeit luxury items. I notified Berger of an item I intended to purchase (counterfeit black Chanel purse) and he stated that depending on the size, the item is sold at true retail value for over \$5,000. I also informed Berger that I planned to purchase a counterfeit mens Louis Vuitton belt which is sold at a true retail value of over \$550. Berger stated that he will be able to determine if the items are counterfeit and will provide a sworn affidavit stating the same if it is. Berger provided me with \$300 of cash from "A ACTION INVESTIGATIONS & SECURITY INC." funds for the purchase of the item(s).												
The funds provided by "A. ACTION INVESTIGATIONS & SECURITY INC." are two \$100 bills and five \$20 bills. The serial numbers are as follows:

On 11/08/2020 I sent a message through INSTAGRAM to account, "@LUXURYCLOSETFLORIDA" inquiring about a black "Chanel" purse that was advertised through the account. On 11/09/2020 the account holder responded that the purse is available for purchase for \$175.00. The account holder also provided their phone number through the INSTAGRAM application as 954-394-4504. This phone number has been previously associated with the suspect, Patzy Aburto (01/11/1979) of 10020 Country Brook Rd, unincorporated Boca Raton FL 33428. Myself and the seller agreed to meet after 6:30 PM in Boca Raton on												
11/10/2020 to make the deal. On 11/10/2020 at 1800 a briefing was held at a predetermined location and all members of the District 7 Street Team were present. Other members of the District 7 Street Team were assigned as security/surveillance and I was assigned to conduct the undercover buy. I texted Aburto and asked her where I should meet her and requested to purchase a mens "Louis" (Louis Vuitton) belt which she has advertised on her INSTAGRAM page. Aburto then provided the address of Cumberland Farms (23077 S. State Rd. 7, Boca Raton FL 33428) for the meeting location and stated that the belt would cost \$85. Aburto agreed on meeting at approximately 1840hrs (see photographs of texts for further information). Prior to my arrival at Cumberland Farms, D/S R. Oragene #7760 maintained surveillance at Aburto's residence where he saw her 2018 Volkswagen Atlas parked in the driveway. I arrived at Cumberland Farms at 1834hrs and texted Aburto that I arrived and at 1841hrs she responded, "coming". D/S Oragene advised that he observed Aburto loading the front passenger seat of her vehicle with unknown items moments prior to entering her vehicle and leaving the residence. Aburto left the house at 1843hrs. Aburto drove straight to the Cumberland Farms constant surveillance was kept on Aburto and her vehicle from her house to the Cumberland Farms shedid not stop or make contact with anyone else prior to the sale. Aburto's arrived at Cumberland Farms at 1846hrs and texted me that she was at Pump #1. I made contact with Aburto at 1847 hours. Aburto was the sole occupant of the vehicle. Aburto handed me a white "Chanel" cloth bag containing a black "Chanel" purse which was the same one advertised on her Instagram, along with a brown paper "Louis Vuitton" box containing a black/grey "Louis Vuitton" belt which was also appeared to be the same belt advertised on her Instagram. Aburto retrieved these items from the front passenger seat, the same area where D/S Oragene observed her loading the items into the vehicle. I then handed Aburto \$260.00 (\$175 for the purse and \$85 for the belt). The investigative funds given to Aburto were (2) \$100 Bills (SN#'s [REDACTED] and (3) \$20 Bills (SN#'s [REDACTED]). The deal was complete at 1848hrs and I left the parking lot at 1849hrs. Aburto was seen leaving the parking lot at 1851hrs and driving north through the parking lot and re-entered her neighborhood. I then met with investigator Justin Berger at District 7. I returned (2) \$20 Bills of unspent investigative funds were returned to Justin Berger (SN#'s [REDACTED]). Justin Berger, acting as an agent/expert witness for both Chanel and Louis Vuitton, photographed and inspected the counterfeit items. Berger, who has been trained by Chanel and Louis Vuitton with over 14 years of experience, immediately identified that the items were counterfeit. Berger took in depth photographs and sent them the manufacturer's. Berger informed me that the manufacturer's security team would send back an affidavit in a few days.

The affidavits provided the following information which certifies that the items sold by Patzy are counterfeit and provides a true retail price for the actual item:</p> <p>CHANEL: Representative ADRIENNE HAHN provided the following signed and sworn statement (see full 9 page affidavit for complete information):</p> <p>"....</p> <p>On November 11, 2020, Chanel received an email from Justin Berger of A Action investigation's &amp; Security, Inc., containing photos of a handbag bearing the Chanel trademarks that was purchased as evidence from Patzy N. Aburto located in Palm Beach, Florida. After reviewing the photos, I determined that the handbag is not a genuine Chanel product. I reached this conclusion based on observations that include the following:</p> <ul style="list-style-type: none"> <li>a) Numerous hardware, labeling, and other features differ from those used in connection with genuine Chanel products,</li> <li>b) The packaging differs from packaging used in connection with Chanel handbags,</li> <li>c) The serial number shown does not match the style of the handbag, and</li> <li>d) The workmanship and materials appear to be dissimilar from that of genuine Chanel products.</li> </ul> <p>10. The approximate Manufacturer Suggested Retail Price (MSRP) for similar genuine Chanel handbags starts at \$5,800 USD.</p> <p>11. Patzy N. Aburto, or any entity connected to Patzy N. Aburto, does not have, nor has ever had, the right or authority to use the CHANEL, Monogram or other Chanel trademarks for any purpose.</p> <p>12. LACOMA</b> swore to the following:</p> <p>"I am the Senior Manager of Criminal Enforcement for Louis Vuitton Malletier (hereinafter "Louis Vuitton") North America based in New York, NY. I have been employed in this capacity since October 2013, and I am familiar with its trademarks and anti-counterfeiting program. I am in receipt of photographs, attached as EXHIBIT A, of a Louis Vuitton trademarked belt ("the item").</p>

<p><b>Based on the statements in the affidavits, there is evidence that Patzy intentionally sold a counterfeit Chanel purse with a true retail value of \$5,800 at a price of \$175 and a Louis Vuitton Belt with a true retail value of \$775.00 at a price of \$85. Both companies advised that the items are counterfeit and that the suspect did not have permission to sell their respective trademarks.</b></p>									
<p><b>On 11/12/2020 I drafted a residential search warrant for the residence of 10020 Country Brook Rd, and the honorable judge James Nutt signed off on the search warrant.</b></p>									
<p><b>On 11/17/2020 at 1030hrs the search warrant was executed and thousands of counterfeit items were seized (see full report for detailed list/photos), along with cash profits derived from the sale of illegal items, and correspondence of Patzy Aburto with the residence. Also, a certified letter from Louis Vuitton's criminal enforcement division was found on Patzy's dresser, addressed to her at 10020 Country Brook Rd, dated December 2019, in which the letter states that Louis Vuitton and U.S. Customs and Border Protection intercepted counterfeit items that were being shipped to her residence. In the detailed letter Louis Vuitton representative, Kenneth King, clearly informs the defendant that selling counterfeit items is illegal and forbidden.</b></p>									
<p><b>Investigator/Authenticator Justin Berger responded, identified several of the items as counterfeit, and advised that based on his extensive training and numerous years of experience, the items seized from Patzy's home are counterfeit and have a true retail value well above \$100,000. The complete inventory, processing, and totaling of the counterfeit items will take place 11/18/2020 at the PBSO evidence unit. See full report for further details.</b></p>									
<p><b>Patzy was taken into custody without incident and transported to PBSO main jail.</b></p>									
<p><b>Based on the above information, I have probable cause to charge Patzy with sale of counterfeit items totaling over \$20,000.00 in true retail value in violation of F.S.S. 831.032(3A2).</b></p>
