The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On Saturday, February 15, 2019, at approximately 12:23 AM, Trooper M. Ivanovici (ID #1732) were traveling southbound on Dale Mabry Highway after making a U-Turn at Lutz Lake Fern Rd, when we observed a white Chevrolet sedan (suspect vehicle) traveling northbound, in the southbound inside lane, directly towards us. Trooper Ivanovici activated my patrol car's emergency lights to conduct a traffic stop on the suspect vehicle and I exited the patrol car. The suspect vehicle transitioned into the outside lane and continued traveling northbound, disregarding the emergency lights. I yelled for the driver to stop, and he subsequently did. I immediately observed the driver a dazed appearance.

Once stopped, I instructed the driver to turn the vehicle off. I approached the driver's side and began speaking with him. While speaking with the driver, I observed his speech was slurred and there was an odor of a consumed alcoholic beverage emitting from his person. Trooper Ivanovici began speaking with the driver and obtained his Driver License. The driver was identified as Paul Cimino (Defendant), via his Florida Driver's License.

I approached the defendant once again and requested that he perform Standardized Field Sobriety Exercises (SFSEs), which he agreed to. Please refer to the attached Alcohol and Drug Influence Report for the defendant's performance on the SFSEs.

After the defendant's poor performance on the SFSEs, I placed him under arrest for DUI. After doing so, I requested that he provide a lawful breath sample, which he refused. I informed the defendant of the State of Florida Implied consent at approximately 12:41 AM, and he refused once again. The defendant was then transported and booked into the Orient Road Jail without incident.

This incident occurred in Hillsborough County, Florida.
