 committed the below acts in my presence. was observed by **ALEX JEAN-LOUIS** who told **OFC SITZ** that he/she saw the arrested person commit the below acts.
 confessed to admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.
 On the **1** day of **March**, **2020** at **17:38** (Specifically include facts constituting cause for arrest.)

The following incident occurred in the city of Delray Beach, Palm Beach County, Florida.

On March 1, 2020 I responded to 301 E Atlantic Ave (Johnnie Browns) in reference to a disorderly customer. Upon arrival Ofc Barnes was in contact with the customer at the west exit to the business. I made contact with the white male who appeared extremely intoxicated and was arguing with Johnnie security (Alex Jean-Louis) and Ofc Barnes. A small crowd was gathering around the white male later identified by FL/DL as Paul Mcdougall, and other customers started filming Mcdougall due to his irate behavior. Jean-Louis requested Mcdougall be trespass warned from the business. In order to keep the safety of the customers and employees of Johnnie Browns. I requested Mcdougall's ID or his name and he refused. I advised him he was no longer detained but was no longer allowed at the business to which he acknowledged he would not return. Immediately after Mcdougall stated he would not return he turned and approached Jean-Louis who was standing at the west entrance of the business. Mcdougall started shouting and cursing at Jean-Louis who stepped back in order to avoid being in a physical altercation.

Based on the aforementioned John Mcdougall is charged with one count of Disorderly Intoxication pursuant to F.S.S. 856.011 and one count of Trespass After Warning pursuant to F.S.S. 810.08 ⁽¹⁾ ₀₉₍₂₃₎
