On 5/13/17 at approximately 0245 I responded to 624 NE 4th Ave in reference to a domestic disturbance. Upon arrival I made contact with Paul Michalzík who immediately stated that he "didn't touch her". I then made contact with [REDACTED] who stated that Paul Michalzík did choked her from behind pinning her neck between his bicep and forearm causing her to lose consciousness. [REDACTED] stated that Michalzík attacked her against her will and she signed an Affidavit of Prosecution indicating that she does
