ON THE 26 DAY OF SEPTEMBER 20 20, AT 8:26 AM PM

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I OBSERVED A BLACK TOYOTA ENTER US HIGHWAY ONE FROM THE AMERICAN LEGION PARKING LOT WITH NO HEAD LIGHTS AND NO TAIL LIGHTS. THE VEHICLE ENTERED THE TURN LANE AND MADE A U-TURN AND BEGAN DRIVING SOUTH ON US HIGHWAY ONE. I BEGAN TO FOLLOW THE VEHICLE, THE VEHICLE REPEATEDLY CROSSED THE RIGHT FOG LINE AND STRADDLED THE CENTER LANE DIVIDER. THE VEHICLE CONTINUED TO SPEED UP, AND SLOW DOWN WITHOUT APPLYING THE BRAKES. UPON ACTIVATION OF MY OVERHEAD EMERGENCY LIGHTS THE VEHICLE SLOWLY BEGAN TO STOP, THEN SUDDENLY TURNED INTO A PARKING SPACE OFF US HIGHWAY ONE AND PLACED THE VEHICLE IN PARK AND THEN INTO REVERSE.

STAWICKI'S EYES WERE BLOOD SHOT, WATERY AND GLASSY. I DETECTED AN ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE EMANATING FROM HIS PERSON.

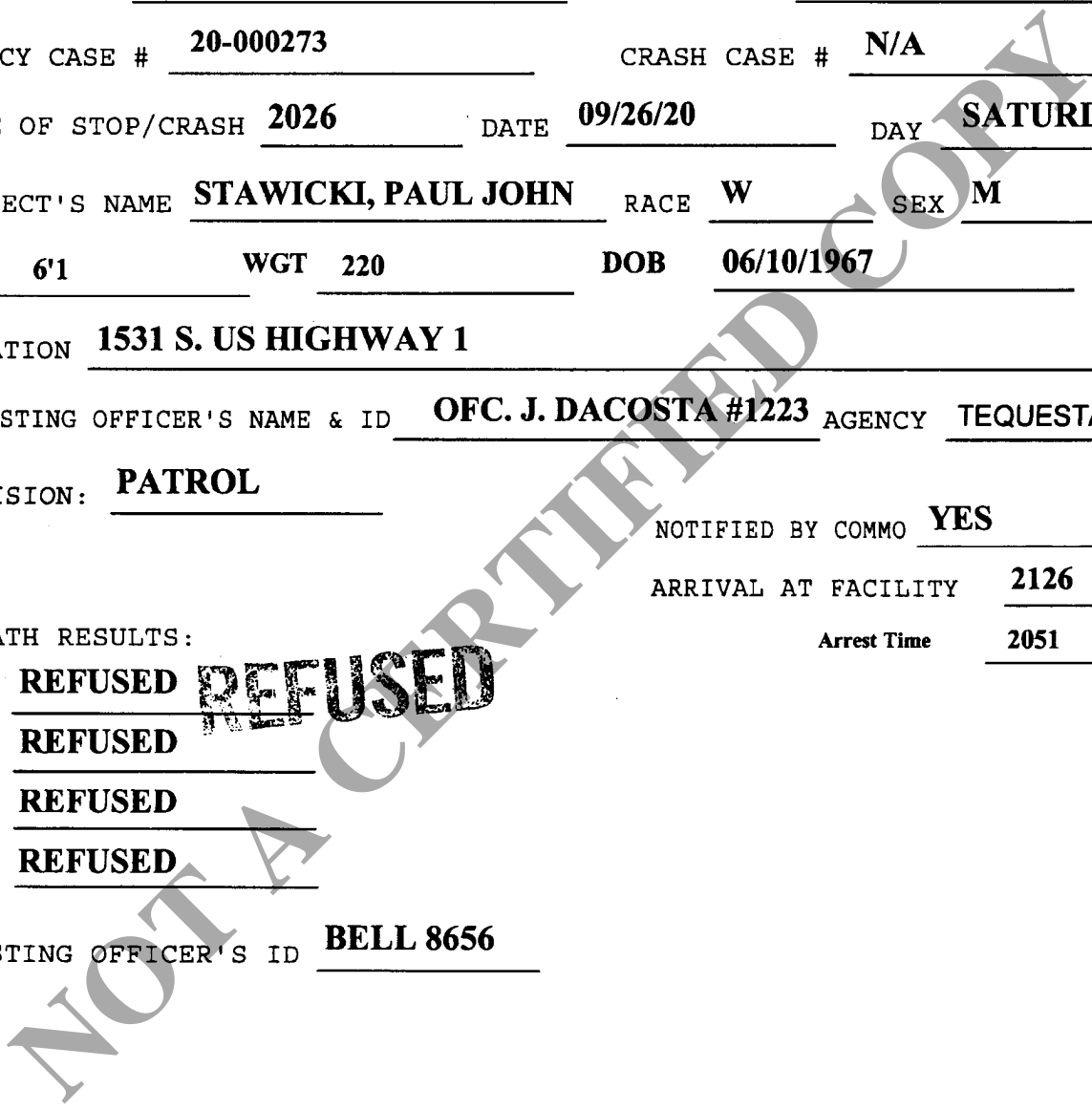
