The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a red 2007 Cadillac XLR, 2 door, Georgia tag PXF2607. The vehicle registration had expired on 8/16/19 (verified via NLETS computer response through the State of Georgia). The defendant drove in a manner in which the vehicle was weaving in the travel lane, crossed onto and over painted lane markers several times, was unable to maintain a consistent speed as he speed up and down inconsistently, and stopped beyond a painted white stop line at a red light so that the vehicle was stopped in the clearly marked pedestrian crosswalk. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery, and his face was flushed. The defendant wore an orange paper bar admissions band on his right wrist. The defendant stated that he drank four (4) alcoholic beverages tonight. The defendant was unsteady exiting the vehicle, and swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant refused to submit to a lawful breath test after being advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
