The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a gray 2019 Dodge Ram pick up truck, Florida tag TGF6T. The defendant was stopped for unlawful speed, as he drove at 45-46 MPH in a properly posted 35 MPH speed limit, swerved one time so that the vehicle crossed over the center painted lane divider, and he stopped beyond a painted white stop line at a steady red traffic light so that the vehicle was into a clearly marked pedestrian crosswalk. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was occasionally slurred. The defendant had difficulty maintaining focus, was somewhat befuddled, and exhibited difficulty with memory as related to what documents had been requested. The defendant displayed poor dexterity as he dropped items from his grasp, spilled items from his pockets onto the driver seat, and had difficulty manipulating his cellphone wallet to retrieve requested documents. The defendant denied consuming alcoholic beverages, and he had a chewing tobacco pouch in his mouth. The defendant had some difficulty following simple instructions. The defendant refused to submit to Field Sobriety Exercises. The defendant did exhibit signs of impairment, and was arrested for DUI. The defendant refused to submit to a lawful breath test after being advised of the Implied Consent Warnings. The defendant was positively identified by his FL DL.
