The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a silver 2018 Toyota RAV-4, 4 door, Florida tag CIVX24. The defendant failed to stop for a steady red traffic light and struck the victims vehicle (a tan 1993 Toyota Camry, 4 door, Florida tag GLBL13) in the intersection. The victim was knocked unconscious in the crash, and was eventually transported to a hospital for treatment. The victim's vehicle sustained approximately \$5,000.00 in damages. The victims vehicle left the roadway and caused approximately \$500.00 in damages to The Bank of Tampa landscaping. The listed witness observed the crash and also placed the defendant as the driver of the Toyota RAV-4, and was the sole occupant of the vehicle. The defendant was unsteady on his feet, swayed while standing, and his speech was slurred. The defendant's eyes were bloodshot, glassy, and watery. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant was advised the civil crash investigation was complete and a criminal DUI investigation was being conducted. The defendant was advised of his Miranda Rights, however, he declined to speak to law enforcement at this time. The defendant refused to participate in Field Sobriety Exercises, despite being advised of the purposes of the FSE's and possible consequences of refusing. The defendant did exhibit signs of impairment, and was arrested for DUI. The defendant refused to submit to a lawful test of breath after being advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
