The driver was identified as Paula Rupert, by their Florida driver license.**

**Upon making contact with Rupert, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Rupert. Rupert had glassy, glazed, and blood shot eyes. Rupert's speech was slurred, and at times difficult to understand. Rupert's movements were slow, deliberate, lethargic with poor coordination. Rupert was wearing a gray t-shirt, blue jeans, and high heel shoes. All the clothing appeared normal.**

**Rupert showed signs of possible impairment so I requested D/S Kysor to conduct an assessment. This affidavit is for supplemental purposes only.**

**PERSONAL CONTACT**

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

D/S Palmer stated he observed the white Chrysler 300 bearing FL tag 3547xl running a stop sign in the 12800 block of Forest Hill BLVD, located in the Village of Wellington, Palm beach County, Florida. While behind the vehicle, D/S Palmer stated he observed the vehicle drifting side to side bouncing between lane dividers. Due to the vehicle failing to stop for a stop sign, D/S Palmer initiated a traffic stop on the vehicle. D/S Palmer later completed a sworn Supplemental Probable Cause Affidavit.

OBSERVATION OF DRIVER:

As I approached the vehicle on the driver side, I detected a strong odor of an unknown alcoholic beverage emitting from the vehicle. In the driver seat behind the wheel, I observed a white female wearing a gray shirt and blue jeans. As I spoke with the driver later identified by FL DL as Paula Rupert the odor of alcohol grew stronger. Rupert had blood shot glassy eyes.

DRIVER'S STATEMENTS:

Paula Rupert spoke with a thick tongue and slurred speech. Rupert initially stated they had three drinks of wine, however later stated they had two at approximately three in the afternoon.

ODORS:

A strong odor of an unknown alcoholic beverage.

**GENERAL OBSERVATIONS**

SPEECH: slurred, spoke with thick tongue

ATTITUDE: cooperative, slowed response

CLOTHING: gray shirt blue jeans

MEDICAL/OTHER: Paula Rupert advised they did not have diabetes, did not have a glass eye, have not had any head trauma nor any injuries. Rupert later stated she had menopause.

Other Observations:

Rupert exhibited blood shot glassy eyes. While in the instructional stance, Rupert displayed an orbital sway, stood with a widened stance as to balance herself and had difficulty standing still.

WALK & TURN:

I placed Rupert in the instructional stance for the Walk and Turn and gave her instructions. After giving and demonstrating the instructions, Rupert confirmed she understood the instructions.

Rupert started too early, exited the instructional stance numerous times, missed heel to toe numerous times, stepped off the line numerous times, took improper number of steps, turned contrary to my instructions and stopped to balance herself.

ONE LEG STAND:

I placed Rupert in the instructional stance for the One Leg Stand and gave her instructions. After giving and demonstrating the instructions, Rupert confirmed she understood the instructions.

Rupert started too soon, placed foot down several times, unable to raise her foot six inches, used her arms for balance and pointed her foot upwards towards the sky contrary to my instructions.

FINGER TO NOSE:

I placed Rupert in the instructional stance for the Finger to Nose and gave her instructions. After giving and demonstrating the instructions, Rupert confirmed she understood the instructions.

Rupert was unable to keep her eyes closed, missed finger to nose every time by placing her finger above, below, left and right of her nose. Rupert was unable to keep her eyes closed, swayed while performing the exercise.

ROMBERG ALPHABET:

I placed Rupert in the instructional stance for the Romberg Alphabet and gave her instructions. After giving and demonstrating the instructions, Rupert confirmed she understood the instructions.

Rupert had difficulty reciting the alphabet and tended to pause as to think. Part way through, Rupert began singing the alphabet.

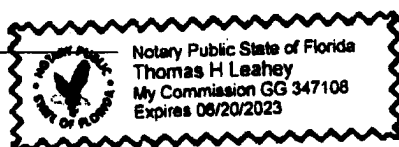

On the 7 day of March 2020 at 23:23  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On 3/7/20 at approximately 2345 hrs, I responded to D/S Palmer's traffic stop the area of Wellington Trc and Randi DR in the Village of Wellington, Palm Beach County, Florida in reference to a possible DUI.

Upon arrival, I observed a white Chrysler 300 bearing FL tag 3547XL facing eastbound on Randi DR approximately sixty feet from Wellington TRC. Upon approaching the vehicle on the passenger side I observed a white female later Identified by FLDL as Paul Rupert (DOB 7/11/65) sitting in the driver seat with her husband in the passenger seat. While speaking with Rupert through the open passenger window Rupert spoke in a strong slurred speech and I detected a strong odor of alcohol from the interior of the vehicle. Due to my observations and the observations of D/S Palmer, I believed Rupert to be impaired of alcohol and requested her to conduct Standardized Field Sobriety Exercises from which she agreed.

After the exercise area was prepared and ensured the area was dry, flat and free of any debris, Rupert was lead to the exercise area. Rupert was placed in the instructional stance for Horizontal Gaze Nystagmus. Rupert was then given and demonstrated the instructions. After ensuring Rupert understood the exercise, she performed the exercise. Rupert exhibited lack of smooth pursuit in both eyes, Nystagmus at maximum deviation, onset Nystagmus prior to 45 degrees in both eyes. While performing the exercise, Rupert displayed an orbital sway.

Rupert was then placed in the instructional stance for the Walk and Stand. Rupert was given instructions and demonstrated the instructions. After ensuring Rupert understood the instructions she performed the exercise. See DUI Probable Cause Affidavit for further Information.

Rupert was asked to provide breath sample, from which she refused. After reading Implied consent and ensuring she understood, Rupert continued to refuse. Rupert was then read Miranda and asked to ask questions, from which she continued to refuse.

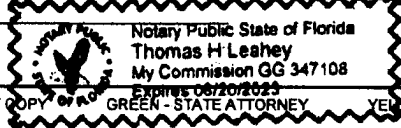
