The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a gray 2014 Ford Fusion (FL TAG #LBDN20) southbound on Armenia Av N in the left lane, when it made a very quick & wide turn onto Kennedy Bl W, then proceeded eastbound. While following behind the vehicle, I paced it at 51 MPH in a posted 40 MPH zone. As the vehicle was driving eastbound for many city blocks, it had the right turn signal on, despite never making a right turn. During the traffic stop for the speeding infraction and additional suspicious driving patterns, the defendant was identified via a NJ DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, confusion with his paperwork, appeared tired/lethargic, was in possession of several empty beer bottles under his seat and stated that he had nothing to drink tonight, despite emitting an odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent and refused to provide a breath sample.
