The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a red 2014 Mercedes (FL TAG #PAYBAE) westbound on Cleveland St W when she accelerated rapidly from the green light and drifted out of her lane of travel. She then made a left turn from a straight-only lane, cutting off 2 vehicles, before drifting out of her lane again and driving down a bicycle lane. During a traffic stop for suspicion of being possibly ill, tired or impaired, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, had difficulty understanding simple conversation, had fumbling fingers, was wearing a red paper nightclub wristband and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a refusal to participate in any SFSEs. While at CBT, she was read Implied Consent and refused to provide a breath sample.
