The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was denied service at a bar for being visibly impaired and was observed getting into a black Range Rover SUV and exiting the parking lot of the establishment. The complainant called for police service due to the defendant driving in an apparent impaired condition and provided the license plate number of the vehicle. Ofc. Bishop located the vehicle and conducted a traffic stop. The vehicle had a delayed reaction to the emergency lights and made several turns before finally stopping. I made contact with the defendant and observed him to have very glassy/watery eyes, slurred speech, and the odor of an alcoholic beverage emanating from his breath. He was unsteady on his feet upon exiting the vehicle and admitted to drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI. The defendant provided breath samples of .234/ .231. The defendant was ID'ed via FL DL.
