The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/11/2020, at approximately 0003 hours, thee affiant was traveling westbound on Water Av w, when the affiant observed a silver Honda Civic, bearing Florida Tag LYHX84 (VIN:19XFB2F50FE033017), to be traveling in front of his patrol vehicle. The affiant observed the vehicle weaving within its lane and fluctuating speed. The affiant conducted a traffic stop on the vehicle to check on the well being of the driver to see whether they were ill, tired, or impaired. Upon contact with the defendant, the affiant detected to the distinct odor of an alcoholic beverage emanating from his breath, observed his eyes to be red/bloodshot and watery, his speech to be slurred, and his movements to be slow and lethargic. The affiant also observed a minor child in the rear passenger seat of the vehicle. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which he agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT, where after a proper 20 minute observation period was conducted, he agreed to provide two lawful samples of his breath. Breath technician F. Mason (ABN:51920) provided the affiant with the results and they are as follows: first BrAC sample .169%, second BrAC sample .177%. The defendant was positively identified via his valid Florida driver's license.
