The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a red 2018 Alfa Romeo, 4 door SUV, Florida tag JTNZ75. The defendant drove in a manner in which the vehicle was weaving in the travel lane, crossed onto painted lane markers several times, and he made a right turn without the use of a turn signal while traffic approached from the rear. The defendant was clearly trying to avoid being followed by law enforcement and turned into the rear parking lot of a closed business and parked. A traffic stop was conducted for the purposes of checking on the driver to determine if he were sick, tired, distracted, or impaired, as well as due to the suspicious nature of his attempted avoidance of law enforcement and pulling into a closed business parking lot. The defendant immediately exited the driver side of the vehicle and refused numerous commands to sit back inside the vehicle. The defendant claimed he was stopping at the hotel, pointing to the closed Trane A/C business. He would later state he was going to the apartments and indicated this same location. The defendant was chewing on gum and a piece of gum was observed on the driver side floorboard area. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were red and watery, and his cheeks were flushed. The defendant refused to follow any verbal commands, was argumentative, and evasive with answers. The defendant eventually provided his FL DL, but forgot other requested documents. The defendant swayed while standing. The defendant denied alcohol consumption. The defendant agreed to perform Field Sobriety Exercises, however, he continued with the ongoing pattern of failing to follow simple instructions, wanting to talk over and interrupt repeatedly, and stonewall as much as he possibly could. The defendant did exhibit signs and clues of impairment, and based on a totality of the circumstance was arrested for DUI. Post arrest the defendant refused to spit out the gum he was chewing until after arrival at Central Booking. The defendant provided breath samples of .108% BrAC and .097% BrAC. The defendant was positively identified by his FL DL.
