Probable Cause

On Thursday, January 20, 2022, at approximately 8:07 A.M., I Sergeant Dailyn Rodriguez (3908) was on Active Patrol. I was in a jurisdictionally marked FHP Police vehicle, equipped with emergency lights and external siren. I was traveling southbound on Interstate 95, just north of 45th Street (Palm Beach County) in lane number two (2). There, I observed a silver in color Infiniti sedan traveling southbound in lane number two (2). As I was traveling behind the vehicle, I observed the silver Infiniti swerved into the left lane and then to the right lane multiple times in a zigzag motion. The Infiniti then swerved back towards the left lane where it began to straddle the HOV lane. I then activated my video recording equipment and began to follow the vehicle. I then activated my lights and siren to attempt to stop the vehicle. As we continued to travel southbound, I observed the vehicle to continue to fail to maintain its lane. The vehicle then activated its right turn signal and changed into lane number three (3). The vehicle then applied its brakes abruptly, almost colliding with the vehicle in front of it. This was consistent with an impaired driver or a driver having a medical emergency.

After approximately one (1) mile, I advised the Lake Worth Regional Communications Center (LWRCC) of my failure to stop. The vehicle continued southbound at highway speeds (ranging from 55 - 70 mph) and continued swerving severely into multiple lanes, coming close to other vehicles, and at one point the right side of the vehicle almost collided with a commercial motor vehicle.

Throughout the entirety of this event, I was following directly behind the vehicle and would get to the left of the vehicle so the driver could see my emergency lights. The driver looked back a few times but continued traveling south. Lieutenant Ruiz (135) was made aware of the failure to stop and was monitoring the channel.

The vehicle continued southbound approximately 5 miles (7 minutes) with myself behind the vehicle with my lights and siren activated. The driver failed to obey the order to stop and continued swerving within its lane. As we continued traveling southbound, the vehicle turned its right turn signal on, and began to travel on the exit lane towards the exit ramp to Southern Boulevard. The vehicle then continued swerving in between lanes, going towards the right, and then the shoulder. As we came up to traffic that was stopped ahead, the vehicle abruptly applied its break, causing the front of the vehicle to collide with the rear of a stopped vehicle in front of it. I ordered the driver to lower his window and get out of the vehicle. The suspect, a White male was then taken into custody without incident.

We later identified the suspect as-

MC CONKEY was the only person in the vehicle and was the registered owner. I asked multiple times if he was ok, in which he stated yes. When questioned why he failed to stop, he stated that he saw my vehicle but was not aware that I was trying to pull him over.
