A witness stated the vehicle pulled to the right shoulder. Upon contact with the vehicle, it was still running with the keys in the ignition. The driver of the vehicle was outside of his vehicle. The driver stated he was the only on in the vehicle and he was trying to go home to Lake Alfred, Florida, from Lakeland, Florida. The driver was unsure of his whereabouts, and unaware that he was traveling the opposite direction from where he was heading. The subject was then advised that if he refuses, I would have to make a decision based off my observations of impairment and if he would be willing to perform FSE's once more. The subject stated "Fuck No!". The subject was then placed under arrest for Driving Under the Influence (DUI). At approximately 10:31 PM, the subject was asked on camera in the backseat of FHP0657 if he would be willing to provide a valid breath sample upon arrival at Orient Road Jail. The subject refused to provide breath. The subject was advised the consequences of refusing to provide breath and was given the opportunity to provide breath again and he refused again. The subject was then transported to Orient Road Jail without incident. This incident occurred in Hillsborough County.
