The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/14/2019, at approximately 2217 hours, at Hillsborough Av W / Hoover Bl N, Tampa, FL 33614, Deputy Karl #254500 conducted a traffic stop on a white Ford Transit van, Wisconsin tag: LV6163 / VIN: NM0LS7BN9CT085218), for driving with no headlights and failing to maintain its lane. I approached the driver's door to assist with the traffic stop and immediately smelled the odor of an alcoholic beverage coming from the driver's window, which I later confirmed to be coming from the driver's breath. I also observed the driver to have slurred speech and bloodshot watery eyes. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly, indicating impairment. Subsequent to arrest, the defendant refused to submit to testing after being read implied consent). The defendant was identified via their Florida driver's license.
