PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 05/14/21 at 2314hrs a motor vehicle crash was reported at the intersection of NE 4th St. and NE 2nd Ave. I responded to crash scene to conduct a DUI investigation with the drivers involved. I met with a driver/witness and identified him by his FL DL as Damon Christopher Hubiak. Hubiak stated he was traveling east on NE 4th St. approaching NE 2nd Ave. Hubiak stated eastbound traffic had a flashing yellow signal. Hubiak stated when he entered the intersection, a white 2017 Chevrolet Silverado pickup failed to stop at the intersection and continued south directly into his path of travel. Hubiak stated he attempted to stop but his vehicle began to skid before striking the Chevrolet. Hubiak stated after both vehicles came to final rest, he observed a white male wearing a gray shirt exit the Chevrolet. Hubiak stated there was nobody else inside the Chevrolet. Hubiak pointed to a white male on scene identifying him as the driver of the Chevrolet. Hubiak's statement was recorded on my body worn camera. I met with the white male driver from the Chevrolet and identified him by his FL DL as Peter Michael Nelson. I informed Nelson I was on scene to conduct a DUI investigation and Ofc. Kitzarow was on scene to conduct the crash investigation. Nelson stated he understood why I was on scene.

OBSERVATION OF DRIVER:

I smelled an odor of an unknown alcoholic beverage coming from Nelson. Nelson's eyes were red and had a glassy appearance. Nelson's pupils were very slow to react to changes in light. Nelson appeared to be agitated toward Hubiak and blamed him for the crash. Nelson's speech was slurred while he was speaking.

During search incident to arrest, I found two Bud Light beer bottle caps in Nelson's right rear pocket. Nelson stated the beer bottle caps were not his.

DRIVER'S STATEMENTS:

Nelson stated he was traveling south on NE 2nd Ave. approaching NE 4th St. Nelson stated he stopped for the red flashing traffic signal and checked both ways for oncoming traffic. Nelson stated he did not see any approaching vehicles and entered the intersection to continue south on NE 2nd Ave. Nelson stated Hubiak's vehicle must have been traveling east at 80mph and struck his Chevrolet. Nelson should have had a clear view for 7 blocks west of the intersection as there are no obstructions to a driver's view. Nelson denied having any medical conditions that would affect his ability to operate a motor vehicle. Nelson denied taking any prescription medications or taking any illegal drugs including marijuana prior to driving. Nelson denied consuming any alcoholic beverages prior to driving. Nelson stated he left his friend's residence on Seacrest Blvd. and was on his way home in Boca Raton, FL when the crash occurred. Nelson asked why I was not investigating Hubiak. Nelson was agitated as I continued to speak with him. I requested Nelson perform roadside tasks and Nelson refused to perform roadside tasks. I informed Nelson of Taylor Warning and Nelson acknowledged he understood Taylor Warning. After Taylor Warning was advised, Nelson again refused to perform roadside tasks.

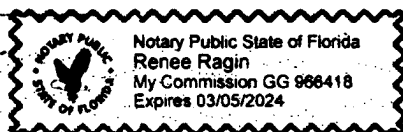

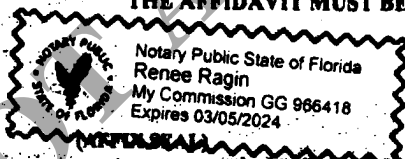
