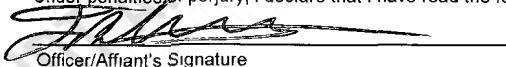
Probable Cause Affidavit

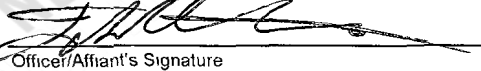
