P R O B A B L E C A U S E S T A T E M E N T	<p>On 11/23/2020 at approximately 1854 hours, I responded to the area of S.R. 811 (S Alternate A1A) and the Three Palms Plaza (2141 S Alternate A1A) in the Town of Jupiter, Palm Beach County, FL in reference to a careless driver. At the time, I was driving a fully-marked Jupiter Police Department patrol vehicle (vehicle 1425), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.</p> <p>Multiple callers advised a white Ford pickup with a bed topper was traveling northbound on S.R. 811 striking the median multiple times, slamming on the brakes, driving slowly, and that traffic was attempting to avoid the vehicle. The callers also advised the vehicle was stopping at green lights and running red lights. Callers provided updated information to dispatch on the whereabouts of the vehicle while officers responded to the area. The vehicle was described as a white Ford F150 bearing FL tag # HVNX28. One caller advised the driving pattern of the truck was so erratic, they were in fear the truck was going to hit the caller's vehicle - forcing the caller to leave the area and cease giving information to Law Enforcement.</p> <p>Master Police Officer (MPO) Banegas (ID 328) located the vehicle (white 2016 Ford pickup) traveling extremely slowly northbound on S.R. 811, repeatedly applying the brakes. MPO Banegas advised the vehicle continued northbound and was straddling the dashed lane dividers separating all three lanes of S.R. 811. MPO Banegas advised he activated his overhead emergency lights and siren to conduct a traffic stop and the vehicle was slow to stop. The vehicle continued northbound on S.R. 811 with MPO Banegas behind, ultimately made a u-turn (almost causing a crash with a southbound vehicle), and continued southbound on S.R. 811 for a significant distance, passing multiple places to pull over before stopping. MPO Banegas further advised he changed the siren tone on his patrol vehicle multiple times in an attempt to capture the attention of the driver with no apparent change in driving behavior before eventually stopping (facing south)</p>

<p>straddling the outside southbound lane of S.R. 811 and the bicycle lane. See supplement from MPO Banegas.</p> <p>When I arrived, I observed the vehicle stopped with MPO Banegas' patrol vehicle (emergency lights activated) behind it. I approached the driver side of the vehicle and noted the vehicle was still running. I observed a white male sitting in the driver seat. I later identified him to be Petr Jelinek (08/30/1982) by his valid Class E Florida driver license.</p> <p>I immediately noted Jelinek had urinated himself and the zipper for his shorts was down. Jelinek's movements were slow and deliberate. Jelinek had to be asked multiple times to produce documentation, and he handed me a stack of expired registrations when I asked him for it. Jelinek had apparent difficulty understanding simple instructions (like turning his vehicle off and placing his keys on the seat). Jelinek placed his keys on the center console. While speaking with Jelinek, I noted his speech was heavily slurred to the extent that he was unable to form coherent sentences. Before asking Jelinek out of the vehicle, I asked if he was diabetic or epileptic. Jelinek advised he was not. Jelinek further advised the police lights were hurting his eyes and that was (somehow) affecting his ability to speak. Jelinek advised he did not have anything to drink and that he was coming from a restaurant, trying to go home.</p> <p>I requested Jelinek exit his vehicle and he complied. Upon exiting, Jelinek propped himself up with his left hand against the driver side of the vehicle. I requested Jelinek walk to the rear of his truck and I noted he was very unsteady on his feet. I advised Jelinek to lean against MPO Banegas' patrol vehicle and asked if he was willing to perform Standardized Field Sobriety Tasks (SFSTs). Jelinek agreed.</p> <p>I first attempted to conduct the Horizontal Gaze Nystagmus (HGN) Task. I am a certified Drug Recognition Expert (IACP # 32395) and I provided the instructions to Jelinek in accordance with my training. Jelinek had pupils of equal approximate size and did not display resting nystagmus. While checking for equal tracking, Jelinek's eyes appeared to track equally but he was moving his head in the direction of the stimulus as it moved. I advised Jelinek to keep his head still multiple times while I attempted to complete the task. Jelinek was not following instructions and I ultimately advised him to hold his hands against his cheeks to prevent his head from moving. Jelinek did so but was still unable to successfully follow the stimulus without moving his head. Throughout the entire duration of the task up to this point, Jelinek was swaying heavily from side to side and front to back to the extent that I thought several times he was going to stumble backwards or fall forwards. Due to the fact that Jelinek was unable to perform this task successfully, I terminated the exercise and advised him to lean against a patrol vehicle for support.</p> <p>Because of Jelinek's unsteadiness on his feet, another officer was requested to stand by</p>

<p>for the remainder of the SFSTs. Jelinek sat on the front push bar of MPO Banegas patrol vehicle. During the time we waited for a third officer, Jelinek appeared to slip in-and-out of consciousness (swaying heavily from side to side and front to back) almost falling forward off the push bumper of the patrol vehicle. I stood close to Jelinek to ensure he did not fall off the push bumper or stumble into passing traffic. During the wait, Jelinek was having mood swings and began to cry.</p> <p>When a third officer arrived, I confirmed Jelinek was still willing to complete SFSTs. He advised he was. I next attempted to conduct the Walk and Turn task. Jelinek had extreme difficulty standing in the starting position (swaying heavily from side to side). I explained the starting position to Jelinek several times and Jelinek routinely stumbled off the line and was generally incapable of standing with his heel touching his toe without stumbling. I attempted multiple times to explain the starting position to Jelinek without success. Jelinek's consistent stumbling put me in fear that he was going to fall and injure himself while performing the SFSTs.</p> <p>For Jelinek's safety, I terminated the SFSTs and placed him under arrest for DUI. Because of Jelinek's apparent in-and-out of consciousness, I was concerned for his health while in my custody and transported him to the Jupiter Medical Center for medical clearance.</p> <p>When I received medical clearance, I transported Jelinek to the Palm Beach County Breath Alcohol Testing Facility (BAT) where I conducted a 20 minute observation period to ensure he did not ingest or regurgitate anything. When the observation period was complete, I requested Jelinek provide a lawful sample of his breath for the purpose of determining the alcohol content. Jelinek initially agreed but questioned the test while the BAT Tech was readying the instrument. I advised Jelinek of Implied Consent (excluding the CDL portion of Implied Consent), confirmed his understanding, and again requested he provide a breath sample. Jelinek refused.</p> <p>Jelinek also refused to sign the DUI citation.</p> <p>Based on the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Petr Jelinek with DUI pursuant to FSS 316.193(1)(a) and Refuse to Sign/Accept Citation pursuant to FSS 318.14(3).</p> <p style="text-align: center;"><b>NOTARIZED</b></p>



I requested that the driver submit to a **X** breath and/or urine test to determine his or her blood alcohol level and/or the presence of chemical or controlled substances. I informed the driver that the refusal to submit to such test(s) would result in the suspension of his or her driving privilege for a period of one (1) year for a first refusal, or for a period of eighteen (18) months if his or her driving privilege had been previously suspended for refusing to submit to a breath, urine or blood test. I also informed the driver that he or she commits a misdemeanor by refusing to submit to a lawful test as requested above if his or her driving privilege has been previously suspended for refusal to submit to a lawful test of his or her breath, urine, or blood. Additionally, I informed the driver that if he or she holds a CDL, or was operating a CMV, refusal will result in the disqualification of the Commercial Driver's License/driving privilege for a period of one (1) year in the case of a first refusal or permanently if he or she has previously been disqualified as a result of a refusal to submit to any such lawful test. Nonetheless, the driver refused to submit to the test(s) requested.




