LakeWorth Regional Communication Center that the driver of a Red Mercury car bearing Florida tag (PYFA41) registered to a Mr. Philip Anthony Goduto Jr (FL DL G330-661-44-468-0) was driving erratic over the road changing lanes southbound on Interstate 95 (State Road 9) approaching 6th AVE.

I initiated a traffic stop on a vehicle matching the description of the BOLOed vehicle on the southbound exit ramp to Lantana Road (State Road 812) in the left inside lane. When I approached the vehicle from the driver's side. I could smell an odor of an alcohol beverage on the driver's breath as he spoke to me. His speech was slurred as he attempted to speak to me. He stated that he had 2 shots of tequila around 2:00 pm. I asked Mr. Goduto for his vehicle registration and he was fumbling around in the vehicle trying to find it. I then requested Mr. Goduto to step out of his vehicle where I notice him stumbling, not able to walk straight and had to be assisted in standing up.

I then told Mr. Goduto that I believed he was impaired and if he was willing to do a series of tasks to see if he was able to drive home. Mr. Goduto stated that he will be refusing to do the test and that he needed a lawyer. I then place Mr. Goduto under arrest for operating a motor vehicle while under the influence and placed him in the back of my patrol car.

Mr. Goduto was taken to the Palm Beach County Jail. All events occurred in Palm Beach County, Florida.
