On 12/12/2019, at approximately 2120 hours, Deputy C. Rosendo (ABN 258021) was conducting traffic control in reference to a vehicle traffic crash which was blocking the westbound lanes of West Hillsborough Ave (HCSO case #19-889341). Deputy Rosendo observed a black Ford F-150, bearing Florida tag EDU1A, with an assigned VIN of 1FTPW12V48FA46273, to be traveling directly towards her. The driver of the Ford F-150 would not follow Deputy Rosendo's orders and continued to drive directly towards Deputy Rosendo. Deputy Rosendo was able to stop the Ford F-150 and made contact with the defendant, who was the sole occupant. Reserve II Captain T. Upon contact with the defendant, he had slurred speech, bloodshot glassy eyes, fumbling fingers and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then agreed to provide a lawful sample of his breath, resulting in a BAC of .239/.237. The defendant was identified via his valid Florida driver's license.
