The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/17/2021, at approximately 2306 hours, I responded to Gibsonton Dr. and Fern Hill Dr. Gibsonton, FL 33534, to assist Deputy Route (ABN:210966) with a traffic crash-no injuries (89443606). The estimated damage amount was approximately, \$12,500.00. The witness, who was also the victim of the traffic crash, identified the defendant as the driver of the vehicle. Deputy Route made contact with the defendant, who was the driver of the vehicle, and observed him to have indicators of impairment. When I made contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, droopy eye lids, and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide lawful breath samples after implied consent was read. The defendant was identified via Florida driver's license.
