<p>On 9-16-20 at approximately 1500hrs, I met with Myers who provided me with a sworn witness statement from the incident on 8-9-20. Myers stated that she and Hoback had been together in a domestic relationship for seven months at the time of this incident and were engaged to be married. When asked where the incident happened, Myers stated it happened at Hoback's business, Nuisance Wildlife Rangers, located at 2115 Lake Worth Rd, Lake Worth, Florida, 33461. Myers stated that on that night, she and Hoback were at the business painting when she left to get food. When Myers returned, she found she was locked out and texted Hoback to let her in but he never responded. After approximately 10 minutes, Hoback exited the building and became enraged that Myers did not "follow his orders" and call him.</p> <p>Once inside, Hoback remained agitated and upset. In an effort to defuse the situation, Myers attempted to leave the building but Hoback blocked her way and prevented her from leaving. After begging Hoback to let her go several times, he eventually relented and let her leave. As Myers paced outside, Hoback exited the building and began yelling at her. He then went to his vehicle and got his shotgun and proceeded to call an ex-girlfriend to "talk him out of killing Myers" at that point fearing for her safety and that Hoback was about to kill her, Myers recorded the two videos I was originally provided.</p> <p>Myers then provided me with a third video of the incident in which she said she was walking away from Hoback down the sidewalk. When she turned around to approach Hoback, he rushed at her and pushed her down.</p> <p>When asked why she approached Hoback again, she stated that the pair had gone to his business in the same vehicle and she had no other way out of the area. She further stated that she was still hoping to defuse the situation and calm Hoback in order to prevent him from harming anyone.</p>

(Specifically include facts constituting cause for arrest.)</p> <p>I then reviewed the third video which begins by showing Myers behind a fence and Hoback by his vehicle yelling profanities. Hoback proceeds to yell at Myers, who is from Canada, to "take your fucking ass back to Canada you fucking retard thats where you belong. This is America bitch." Hoback then begins screaming "Fuck Canada! Fuck Canada!" At which point Myers re-approaches Hoback in the video. Hoback proceeds to tell her "Canada just makes dumb ass bitches like you, fuck you bitch." Hoback can be seen walking towards Myers asking her "what chu gonna do, wanna do something about it, what chu gonna do." Hoback then says "you ain't gonna do shit" as he lunges towards Myers and violently shoves her to the ground. The camera goes black but Hoback can be heard taunting Myers saying "What chu gonna do, What chu gonna do." The video continues with Hoback telling Myers to leave and get away from him. When Myers asks why he would do that to her, Hoback taunts her again by saying "you ain't so tough are you, you ain't so tough are you, you wanna do something or not?" the video ends with Hoback walking away saying "I wish I never met you, I hate you."</p> <p>I then conducted a routine computer search and learned that on 8/27/20, Hoback was arrested for domestic battery by strangulation against Myers at their residence in West Palm Beach. In the report, Myers accused Hoback of infidelity. After being confronted, Hoback placed Myers in a "choke-hold." Hoback also threw Myers to the ground, slammed her face into the concrete, then got on top of her and repeatedly struck her in the back of the head. Pictures were taken of Myers injuries and the incident was documented under PBSO case number 20-101501.</p> <p>All the videos provided by Myers, to include the video for PBSO case number 20-101501, were placed into evidence.</p> <p>Based on my observations, investigation, and the information provided, I believe there is probable cause to arrest Hoback for violating F.S.S. 784.03(1a1)/Domestic Battery as Hoback and Myers were living as a family unit and Hoback actually and intentionally touched Myers against her will when he violently shoved her to the ground on 8/9/20.</p> <p>There is also probable cause to believe that Hoback violated F.S.S. 784.021(a)/Domestic Aggravated Assault when he made an intentional, unlawful threat by word or act to do violence to Myers with a deadly weapon, coupled with an apparent ability to do so (holding the shotgun and chambering a round), and doing that created a well-founded fear in Myers that such violence was imminent.</p>
