 The defendant was operating a red 2016 Volkswagen Jetta, 4 door, Florida tag AEQC77. The defendant was stopped for driving at night without head lights on and unlawful speed. The defendant drove at a speed of 59 MPH in a properly posted 35 MPH speed limit, which was visually estimated and patrol car paced (TPD unit 5055). The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were red, watery, and glassy. The defendant's face and neck was flushed. The defendant stated that he drank one alcoholic beverage (beer) just prior to driving. The defendant was unsteady exiting the vehicle, using the vehicle to assist, and he swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purpose of determining its alcohol content after he was advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
