P R O B A B L E	<p>On July 2, 2021 at approximately 0316 hrs, I was on routine patrol in my marked police vehicle traveling north on N AlA, Jupiter. I observed a white sport utility vehicle exit the Alhambra Plaza and head south towards me. My windows were down and I could hear a noise come from the vehicle that sounded like a flat tire. I made a U-turn and tried to catch up the vehicle. I got closer to the vehicle when I noticed the vehicle was jerking to the left and right in the lane.</p>								
	<p>I caught up to the vehicle at the Jupiter by the Sea condominium complex located at 2000 block of S AlA. The Entrance gates were closed. The vehicle was attempting to turn around when I initiated my emergency light and conduct a traffic stop. The vehicle was identified as a 2016 Ford Escape bearing Michigan tag DUY6444. The driver, Lauritz Phillip Pillers W/M 4/11/92 was later identified by his Michigan driver's license. I also confirmed Pillers car had a flat front left tire that was beginning to shred apart and smoking.</p>								
	<p>I asked Pillers if he knew he had a flat tire. He responded with, "my back right." I checked the back right and there did not appear to be anything wrong with it. Pillers went on to say he was coming from West Palm Beach and heading to Abacoa where he lives. I asked him where he is right now and he replied with, "Beyond Abacoa." During my conversation with Pillers I could smell a strong odor of an unknown alcoholic beverage coming from his breath.</p>								
	<p>I asked if he had been drinking and he said he drank about 3 liters of beer multiple hours ago. He clarified that to be 6 hours ago. Pillers agreed to participate in field sobriety exercises.</p>



I placed him under arrest at 0353 hrs. I read Pillers the Jupiter Police Department Roadside DUI Breath Request and he refused to submit. I read Pillers the Jupiter Police Department Implied Consent for Breath and he refused to submit at 0409 hrs. I then transported Pillers to the Jupiter Police Department for completion of arrest paperwork.						
	I have probable cause to believe that Pillers was in actual physical control of a vehicle while under the influence of an alcoholic beverage, chemical or controlled substance to the point that his normal faculties were impaired. He was issued a court date of August 4, 2021.
