The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 10/20/2019, at approximately 0451 hours, near the intersection of Big Bend Road and Highway 301 South, Riverview, Florida 33569 the defendant was observed by Deputy J. Maiello ABN: 235946 moments following a hit and run traffic crash (88689854). The defendant was also observed by an independent witness causing the traffic crash. Upon Deputy Maiello's contact with the defendant who was in the driver's seat and in physical control of a blue 2008 Dodge Charger bearing Florida tag EAQY88 with an assigned VIN of 2B3KA43G48H220076, he observed multiple indicators of impairment. Upon the affiant's contact with the defendant, I observed her to have bloodshot watery/glassy eyes, slurred speech, a red in color face, she was unsteady on his feet, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant elected to participate in field sobriety exercise and while doing so, she showed further indicators of impairment. Search incident to arrest revealed the defendant to be in possession of a prescribed substance (Ibuprofen 600 MG Tablets) in the name of "Christina Smith". The medication was found in the defendant's MK black and lime green purse. The defendant was arrested for DUI and transported to Central Breath Testing where she provided to lawful breath samples of .207 and .205. The defendant caused approximately \$2,000 worth of vehicle damage. The defendant was further identified by her DAVID photograph.
