The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 9/19/2020, at approximately 0402 hours, at Bruce B Downs Bl. / Bearss Av. E., Tampa, FL 33613, Deputy Estrada (ABN 259135) responded to a traffic crash call for service and made contact with the defendant and the witness. The witness observed the crash occur and observed the defendant behind the wheel of the vehicle, a black Honda (bearing FL tag IKPK13 / VIN: 19XFB2F57FE076429). The vehicle was disabled in an embankment, but there was no additional property damage. Upon making contact with the defendant, he observed the defendant to have dilated pupils, slurred speech, and he detected the odor of an alcoholic beverage emitting from his breath. He also observed the defendant swaying and struggling to maintain his balance. Based on the observed indicators of impairment, Deputy Estrada requested a DUI investigator respond to the scene. Deputy Hake (ABN 255737) completed the traffic crash investigation (see HCSO case 20-602681 and DHSMV crash report 89129634-01). Upon my arrival, I observed the same indicators of impairment listed above. The witness also stated she observed the defendant stumbling as he exited the vehicle. Post Miranda, the defendant admitted to coming from Mixers Bar and consuming approximately 2 beers. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .194/.192 after a twenty minute observation period. The defendant identified himself verbally, which was confirmed via his DAVID photograph.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
